City awarded parks grant for playground

The City of Glendale has been awarded grant funds to participate in a joint project to bring major playground enhancements to North Glendale Elementary School, 765 N. Sappington Road.

The Municipal Parks Grant Commission has approved a \$176,826 grant for the accessibility improvement project. The grant will cover 80 percent of the cost of the project. The remaining 20 percent will be shared by the City, Kirkwood School District and the North Glendale Parent Teacher Organization.

"This playground area remains ADA non-compliant and non-accessible to individuals with disabilities," City Administrator Frank Myers said in the city's grant application. "The

awarding of this grant will provide inclusive play areas and exceed accessibility guidelines for playgrounds."

The enhanced playground will be used by students during

Schiff — alderman, judge, musician — dies at 79

Ward I Alderman and former St. Louis County Circuit Judge Martin Schiff died Jan. 3 at age 79. He had suffered a stroke at home on New Year's Eve, and died at St. Mary's Medical Center.

Judge Schiff was first elected to the Glendale Board of Alderman in 2004 and was planning to run for re-election in the April 6 election.

Judge Schiff leaves his wife, Kathleen Schiff, four children and three stepchildren, eight grandchildren, and a sister, Martha Schiff of Ballwin.

Schiff earned a law degree in 1958 from Washington University School of Law after

returning from service in the U.S. Navy during the Korean War. He practiced law for 30 years before being appointed as a judge in the St. Louis County Circuit Court in 1988. During his 12 years on the bench, he spent five years as an administrative judge of the Family Court. He retired as Circuit Court Judge in Division 8 at the mandatory age of 70 in 2000. After retirement, he worked part-time as a senior judge in Missouri.

Born in Akron, Ohio, Schiff grew up in Webster Groves and attended Bristol Elementary School and Webster Groves High

Dear Residents:

As we move into spring, I would like to share with you some of the great things that are happening in our City. During these challeng-

ing economic times, the City of Glendale remains committed to building upon the high quality of life presently enjoyed by our residents while controlling costs wherever possible.

Recently, all of you should have received new 65-gallon recycling carts designed to better meet your recycling needs and protect our environment. These carts were almost exclusively paid for through grants written by our staff. The City also has collaborated with the Kirkwood School District and PTO in procuring \$176,826 in grant funds to replace the aging playground equipment at North Glendale Elementary School. In addition, the City has completely revamped its website to better serve you and those interested in becoming a part of our community. One new feature of this website is a citizen registration component to

connect you with timely information about important community activities and issues. Please be sure to visit our new website at www.glendalemo.org.

We expect that you soon will receive through the mail a form from the U.S. Census Bureau. Approximately 25 percent of all City revenues are based upon the size of the City's population. Therefore, in order to continue to offer the very best services we can to our residents, we are counting on you to be counted in this census. Also remember to make sure that everyone who resides at your residence as of April 1 is counted. More information about the census can be obtained on our new website and by calling City Hall.

As you have heard from me many times, the City of Glendale is blessed to have an outstanding workforce committed to the highest standards of excellence. Over the past several months, five of our employees were recognized for outstanding achievements. In November, Lt. Joe Laramie and the Glendale Police Department were awarded the 2009 Outstanding Local Government Achievement Award by the East-West Gateway Council of Governments for its role in developing and administering the Missouri Internet Crimes Against Children Task Force. In December, Police Chief Richard Black received the 2009 Donald "Red" Loehr

Outstanding Police Chief Award from the Missouri Police Chiefs Association. Also, Officer Steven DeBisschop was named the "Michael P. Pounds Employee of the Year," Officer Matt Pappert received the 2009 City of Glendale Community Service Award and Fire Captain Brad Kauffeld received the Fire Department's Phoenix Award. Voters to decide on three aldermen, transit sales tax, education board members

Glendale voters will be asked on the April 6 ballot to choose three aldermen, two Kirkwood School Board directors and one Community College trustee and vote on a countywide sales tax for public transportation.

Three Board of Aldermen candidates are running unopposed for two-year terms representing all three Glendale wards.

In Ward I, Tom Schoemehl is running unopposed to replace the late Martin Schiff, who died Jan. 3.

Ward II incumbent alderman Paul Roettger is running for reelection, and Ward III incumbent Dan Sullivan is running for his second term.

- Voters throughout St. Louis County will decide on Proposition A, which would impose a countywide sales tax of one-half of one percent to provide funds for public

transportation projects. The revenue would fund restoration, operation and expansion of MetroLink, MetroBus and disabled and senior citizens transportation.

The increased tax would be in addition to an existing one-fourth-cent sales tax for public transportation. A simple majority is required for passage.

- In the Kirkwood School District, voters will select two candidates to serve three-year terms on the Board of Election. The candidates are: Angie Bay of Des Peres, Kathy Harris of Kirkwood and William (Bill) Bauer of Kirkwood.

- In the Junior College District of St. Louis—St. Louis County, Subdistrict 4, voters will select one candidate for a six-year term on the Board of Trustees. The candidates are: Tina A. Odo of Wildwood, Robert (Michael) Johns of Glendale, Rob-

ert C. Nelson of Kirkwood and Craig H. Larson of Manchester.

Political signs

As the election nears, Glendale officials remind residents of city regulations regarding campaign signs. Rules include:

- Political signs in a residential zone may not be more than 8 square feet in area.
- Signs may not be illuminated.
- Signs may not be posted more than 30 days before an election and must be removed within three days after the election.
- Signs may not be closer than 15 feet of the paved portion of the street.
- No signs may be posted on private property without the owner's permission.
- No more than two signs per lot are allowed.

Glendale PD receives OLGA Award from East-West Gateway

The Glendale Police Department has received a 2009 Outstanding Local Government Achievement Award for the Missouri Internet Crimes Against Children Task Force. The award, given by the East-West Gateway Council of Governments, recognizes the department's commitment and unique effort as the managing agency for this program in the battle against online child exploitation.

The award was presented on Nov. 13 at East-West Gateway's 44th Annual Meeting, an annual event in which it honors local governments, public officials and projects that are making special contributions to their community and the region. The Glendale Police Department is one of two honorees in the category of Exemplary Accomplishment by a Local Government Jurisdiction, Agency or Individual.

The Missouri ICAC Task Force was born when the Glendale Police Department received a \$45,000 grant in 2001 from the Department of Justice's Office of Juvenile Justice and Delinquency Prevention

to establish a statewide program educating the public about and conducting investigations into crimes against children on the Internet. Missouri ICAC is now one of 61 such programs across the United States.

The Task Force is responsible for criminal and forensic computer investigations, as well as for providing education to the community and other law enforcement entities across the state in the areas of internet safety and cyber bullying.

Glendale Police Lt. Joseph Laramie serves as the director of the Task Force and provides presentations on these subjects throughout Missouri and at national conferences. The Glendale Police Department and the City of

Glendale serve as the managing agency and fiduciary agent for the Task Force.

Tick tock: Census form deadline approaches

The clock is ticking on the 2010 Census. The City of Glendale is urging residents to fill out their Census forms and turn them in by the April 1 deadline, so that Glendale will receive its fair share of taxes for the next decade.

"It is important for Glendale residents to accurately complete the 2010

census because several taxes that the City of Glendale receives are based on population," said City Administrator Frank Myers.

We have been informed that in March, households throughout the country will begin receiving census questionnaires consisting of 10 questions designed to determine the size and makeup of the U.S. population. Every 10 years, the U.S. Census Bureau conducts a complete count of the population as mandated by the Constitution. All residents of all ages, races and

ethnic groups, whether citizens or not, must be counted by December 2010.

Residents should be sure to count all people living in the home as of April 1, including extended family members, college-age children or friends.

The form asks only for name, sex, age, date of birth, race, ethnicity, relationship and housing tenure. Strict laws protect the confidentiality of respondents and the personal information they provide.

Householders who do not return their census forms by April 1 will receive visits by census takers from April through July. The Census Bureau is required to deliver the population counts to the president on Dec. 31.

City honors Police employees

Two Police Department employees were honored by the City of Glendale at its annual employee appreciation luncheon on Dec. 18.

Police Officer Steven DeBisschop was nominated by his fellow employees as the 2009 City of Glendale Michael P. Pounds Municipal Employee of the Year. Qualities of the recipient of this award include excellent overall performance, high productivity, a strong sense of pride and loyalty to the City of Glendale and noteworthy accomplishments during his or her career. DeBisschop is a 10-year veteran in law enforcement and a six-year employee of the City of Glendale. His extraordinary investigative work has resulted in the apprehension and conviction of an armed home invasion perpetrator in January 2009. When a series of thefts from automobiles occurred in Glendale in April 2009, these extraordinary investigative skills resulted in the arrest of two suspects.

DeBisschop also was the recipient previously of the prestigious John J. McAtee Award for his compassion, patience and skill in effectively dealing with an armed mentally ill 21-year-old resident who was threatening to kill his parents with a large butcher knife. This officer used a non-lethal Taser to subdue the individual, who was taken to St. Anthony's Hospital for mental treatment; and DeBisschop continued to work with this resident, who is now functioning well in a group home environment near Farmington.

Police Officer Matthew Pappert was nominated by his fellow employees as the 2009 City of Glendale Community

Service Award winner. He was named for this honor because he freely gives of his spare time supporting the needs of others less fortunate. He is a member of the Shriners and devotes personal time attending such charitable events as benefits for the National Alliance on Mental Illness, the Siteman Cancer Center and Stray Rescue. He also volunteers his time to escort children on tours at the Shriners Hospital for Children in St. Louis.

New and improved solicitor identification process

The City of Glendale has initiated a new and improved way of identifying solicitors and peddlers working in your neighborhood. Previously, it was difficult to identify those who were authorized to solicit or peddle in the City because a company would obtain a permit, but often would not provide their employees with copies of the permit.

Late last year, the City purchased a new photo ID card machine and now will require each authorized solicitor or peddler to obtain a photo ID card. The ID will identify the seller as an "Authorized Solicitor." The card clearly identifies the individuals with

name, company and dates of issue and expiration and must be worn at all times when soliciting in the city. Residents always are encouraged to contact City Hall or the Police Department if they suspect someone is soliciting illegally within the City.

Black named 2009 top police chief

Glendale Police Chief Richard Black, a 40-plus-year veteran of the Glendale Police Department, was selected as the recipient of the Missouri Police Chiefs Association's 2009 Donald "Red" Loehr Outstanding Police Chief Award.

Black also was presented with a Missouri House of Representatives Resolution honoring him for his years of service and as Police Chief of the Year. The resolution was offered by Rep. Jeanne Kirkton and presented by former representative and current Missouri Department of Health Director Margaret Donnelly, who is also Black's sister-in-law.

"On behalf of the Missouri Police Chiefs' Association, I would like to congratulate you on being selected for this award and thank you for your professionalism, dedication, and commitment to the Missouri law enforcement community," said Sheldon L. Lineback, executive director for the association, in notifying Black of the award.

Top Glendale firefighter receives 2009 Phoenix Award

Each year the Fire Department commends one employee for his or her outstanding performance throughout the year at an appreciation dinner held at an area restaurant. This year, the Phoenix Award was presented to Capt. Brad Kauffeld, who was honored for his cost-saving initiatives for the City of Glendale.

The first of these initiatives highlights Kauffeld's investigative efforts when purchasing new equipment for the Fire Department. He thoroughly investigates each piece of equipment needed to determine quality, ease of use and cost effectiveness.

In addition, Kauffeld's efforts as maintenance officer have saved the City thousands of dollars over the use of contracted services, said Fire Chief Larry Zeitzmann. Kauffeld performs nearly all of the preventive maintenance and some of the emergency repairs to all of the apparatus and vehicles in the Fire Department fleet.

Flag disposal

If the family's star-spangled banner looked a little tattered and torn under the rockets' red glare during the latest holiday,

it may be time to retire that flag. Citizens may drop off their ragged American flags at the Glendale Fire Department at any time.

The Fire Department will turn the retired flags over to the local Boy Scout Troop, which will destroy them properly. Boy Scouts earn badges for conducting flag disposal.

Spring storm preparedness

With spring quickly approaching, spring thunderstorms will soon follow. In order for everyone to stay as safe as possible, the Fire Department offers a few guidelines for preparing for the storm season and what to do during after these storms.

Citizens should familiarize themselves with common thunderstorm and lightning terms to help identify a thunderstorm hazard:

Severe Thunderstorm Watch: Tells when and where severe thunderstorms are likely to occur. Watch the sky and stay tuned to NOAA Weather Radio, commercial radio or television for information.

Severe Thunderstorm Warning: Issued when severe weather has been reported by spotters or indicated by radar. Warnings indicate imminent danger to life and property to those in the path of the storm.

Tornado Watch: This means that conditions are favorable for tornado development. This is the time to prepare and keep alert by listening to radio, television

or weather radio for the latest weather information. Parents should know where their children are. All citizens should have a plan for where to go and what to do if a tornado threatens.

Tornado Warning: This means a tornado has been sighted or indicated by radar. People in the path of the storm should take immediate life-saving actions.

The St. Louis County Office of Emergency Management will activate the outdoor warning siren system whenever the National Weather Service issues a tornado warning for a Missouri county adjacent to St. Louis County *and* when the direction of the storm path poses a threat to St. Louis County. If a tornado warning is subsequently issued for St. Louis County, the sirens again will be activated. This policy was created to provide more time for our citizens to gather information and seek shelter.

If the tornado warning sirens are activated (a three- to five-minute steady alert tone), individuals should immediately seek information then shelter, if recommended. Check local television and radio broadcasts or alerts issued by the National Weather Service over any NWS "tone alert weather monitor." Immediate evacuation may not always be warranted based on the location of the storm, so it is important that local media sources or weather radios be monitored for the duration of the warning.

Select Link, a rapid communication system that enables the city to deliver emergency messages to residents in a timely manner.

The emergency messages could be warnings of severe weather, criminal activity or a hazardous spill, delivered to citizens through home phone, cell phone,

text message, fax or e-mail.

City rolls out new 65-gallon recycling carts

By now, most Glendale households have received their new 65-gallon roll-out recycling carts.

The new carts, to be used for single-stream recycling, were distributed to homes Jan. 20 to 22. Residents have the option to turn in their old recycling bins if left empty at the curb on Mondays.

About 100 residents attended a Recycling Fair held at City Hall Jan. 16 to acquaint residents with the new carts and the recycling program. The recycling pickup schedule will remain the same and will continue to be operated by the city's waste hauler, Allied Waste.

Due to an error by the supplier, an incorrect label was placed on the lids of the new recycling carts regarding some recyclable items. The lids are being replaced with new lids containing the correct information. Contrary to the original incorrect labels,



recyclable items DO include pizza boxes, cardboard egg cartons (but not foam), juice boxes, juice bags and aluminum foil.

Since delivery of the new carts, Allied Waste has seen a spike in recycling efforts in Glendale, City officials said. The larger carts allow residents to recycle more items, and more recycled items mean lower costs for disposal of regular waste.

Last year, the city received two grants totaling \$83,634 to provide each of the City's 2,265 households with a 65-gallon cart.

Residents who still have questions or concerns about the new carts may call City Hall at 965-3600.

Residents will be given the opportunity to tour the Allied Waste facility. Please call City Hall to arrange a tour.

Residents now may pay trash bills by bank draft, court fines through online service

Residents who wish to reduce paper bills and checks may receive their Glendale trash bills through e-mail and pay them by automatic bank draft.

The City of Glendale started sending e-bills early last year and later began offering the option of automatic bank draft, allowing the city to withdraw funds directly from residents' bank accounts to pay trash bills.

The city put the bank draft payments into action in January, with 26 customers, representing about 1 percent of Glendale households, participating.

"I would like to see this figure dramatically increase as it saves the City time in processing check information," said Finance Officer Dan Lawrence. "The residents like it as they do not have to write a check, saving them time as well as the cost of postage and envelopes."

In addition, a new online payment option is available for traffic ticket payments. IPayCourt is a new feature that allows citizens to pay traffic tickets online without having to appear in court or at the court office. Not all tickets are payable online—the service is only available for tickets that do not require a court appearance.

Partial payments are not accepted. Participants must provide the ticket number and driver's last name to access this feature. The secure website allows the customer to safely pay tickets online using Visa, Mastercard or Discover.

Garage sale signs subject to regulations

Spring weather brings opportunities for great bargains for garage sale shoppers.

The City of Glendale reminds residents holding garage sales that the city carries several restrictions regarding signs that advertise these sales.

The restrictions include:

- Sale signs may not be placed within 15 feet of the paved portion of the street.
- Signs may not be larger than four square feet.
- No more than one sign may be placed in each lot.
- Signs may be placed only between the hours of 7 a.m. and 8 p.m. and only on the day of the sale.
- Any signs posted along Lockwood Boulevard or Berry Road must have a permit from the St. Louis County Highway Department.

normal school hours and will be available for community use any time outside of the normal instructional day.

"I'm looking for it to serve not only the North Glendale students but also the whole community for the next 25 years," said North Glendale Principal Todd Benben.

Planned improvements include installing accessible playground equipment that meets current playground compliance standards and exceeds current Americans with Disabilities Act accessibility standards. The new equipment will be a one-piece, multilevel apparatus with more elements for upper-body fitness; a climbing rock with imbedded fossils; tunnels; and a minimum of four slides. One of the slides will be metal, as plastic can cause a problem with friction for cochlear implants, Benben said.

The equipment will be installed on a poured-in-place rubberized surface. Several other site improvements will be made to improve the overall safety of the area and to increase accessibility. The new entrance will include new steps adjacent to the existing ramp; a retaining wall doubling as a seating area; an improved sidewalk along the playground; new railings; and new landscaping that retains an existing tree.

As Glendale has no city-owned park, North Glendale Elementary School has the only outdoor recreation facility in the center core of the city. So the City and the school district have joined forces before to benefit the facility. In 1997, they collaborated to improve the playground and create a school/community park area. In addition to the playground equipment, benches and a drinking fountain, the North Glendale grounds include a quarter-mile asphalt walking/running path. In spring 2008, the school dedicated a new outdoor learning pavilion in honor of former principal Tom Waltz, who retired in 2006. The pavilion was funded by a grant awarded to the City, the school district and the PTO.

The playground gets heavy use during off-school hours, Benben said, by organized and casual sports teams as well as kite flyers, golfers, exercisers and other

individuals.

The City has committed to contributing 5 percent of the local match of \$50,457, while Kirkwood School District would cover 8 percent and the PTO, 7 percent.

The grant application was submitted in October, and the award was announced Dec. 29. Construction is scheduled to take place during the school's summer vacation in June through mid-August.
